Firm News: Greetings from Palo Alto

Sanford Heisler Sharp is pleased to announce the opening of our new office in **Palo Alto, California**, where our attorneys will continue to bring cases in employment discrimination, wage and hour violations, and whistleblower and qui tam matters with a particular focus on Silicon Valley workers and tech-focused investment professionals and lawyers. Recent Settlements/Arbitration Awards

The firm reached a \$13.75 million settlement in a 401(k) mismanagement class action against Walgreens. Partners Charles Field and David Tracey conducted a lengthy investigation and successfully filed claims that Walgreens violated ERISA's duty of prudence standard by retaining ten Northern Trust Target Date Funds in Walgreens' retirement plan despite nearly a decade of poor investment performance relative to established benchmarks.

The firm secured an \$8.3 million arbitration award, including \$650,000 in punitive damages and \$500,000 for emotional distress, in a breach of oral contract and fraud case against InnoGrit Corporation, a multinational semiconductor company based in Silicon Valley, and its CEO Zining Wu. Qiaojing Ella Zheng, Co-Managing Partner of the firm's Palo Alto and San Francisco offices and Chair of the Asian American Litigation and Finance Practice Group, and Leigh Anne St. Charles, Managing Partner of the firm's Nashville office, represented the plaintiff, Dr. Yuhui David Chen, who co-founded InnoGrit but was wrongfully denied his rightful equity stake in the Company promised by his co-founder.

The firm reached a \$2.85 million settlement as co-counsel in a case against Aurora Behavioral Health Care – Santa Rosa, LLC, an acute psychiatric hospital operated by Signature Healthcare Services, LLC, over understaffing and unsafe working conditions. The settlement, which includes programmatic relief to review hospital staffing and protect employees from whistleblower retaliation, was brought under the California Private Attorney General Act ("PAGA") for pervasive violations of the California Occupational Safety and Health Act ("Cal/OSHA"). Partners Andrew Melzer and Qiaojing Ella Zheng co-led the three-year investigation, with Partner Ed Chapin and Associate Alok Nadig.

The firm reached a \$2.1 million settlement in a decade-long litigation of a wage and hour class action against telecom provider Alaska Communications Systems, which unlawfully exempted 74 sales employees from overtime dating back to 2011. Partner and Wage and Hour Practice Group Co-Chair Michael Palmer served as lead counsel, alongside Partner and Discrimination and Harassment Practice Group Co-Chair Melinda Koster and Senior Litigation Counsel Nicole Wiitala.

Discrimination and Civil Rights Case Highlights

Adnan Syed case (a matter featured on the podcast 'Serial'): Partner and Criminal/Sexual Violence Practice Group Co-Chair Steve Kelly and Associate Ari Rubin are representing pro bono the family of murder victim Hae Min Lee over numerous alleged constitutional and statutory crime victims' rights violations. In September, a Baltimore circuit court vacated Syed's 2000 conviction for Lee's murder. Read more about the case in *The Baltimore Sun* and *Rolling Stone*.

Harvard University Lawsuit: Sanford Heisler Sharp's Title IX complaint, filed on February 8, 2022, alleges that Harvard University ignored a pattern of alleged sexual harassment and retaliation by a well-known anthropology professor against three of his female doctoral candidate students. Partner Russell Kornblith, Senior Litigation Counsel Carolin Guentert, and Associate Sean Ouellette represent the plaintiffs. Read more in The New York Times and The Boston Globe.

Midshipman-cadet suits against Maersk Line, Limited:

The firm's complaint, filed on June 14, 2022, on behalf of two female cadets of the Merchant Marine Academy against shipping giant Maersk, alleges that the company failed to protect the cadets from sexual assault and sexual harassment during their compulsory "Sea Year" service aboard the Maerskoperated vessel. Christine Dunn and Steve Kelly, Co-Chairs of the firm's Criminal/Sexual Violence Practice, represent the plaintiffs; both cases were recently successfully resolved. Ghost Guns Lawsuit: On June 1, 2022, Sanford Heisler Sharp joined with the City of Baltimore and Brady, a national gun violence prevention organization, in filing a public nuisance suit against Polymer80, which advertises, manufactures, and sells easy-to-assemble gun kits that account for 91% of all "ghost guns" seized by Baltimore police. Partner and Criminal/ Sexual Violence Practice Group Co-Chair Steve Kelly, Staff Attorney Albert Powell, and Associate James Hannaway are co-counsel. Financial Services Class Actions

Snyder, et al. v. UnitedHealth, et al.: A 401(k) mismanagement class action against UnitedHealth Group in the U.S. District Court for the District of Minnesota, representing a certified class of 150,000 individuals. The Amended Complaint contains information about how the senior leadership of UnitedHealth personally intervened to keep employees' retirement funds in a poorly performing Wells Fargo Fund Suite because Wells Fargo was a critical customer and financier of UnitedHealth. Charles Field, San Diego Managing Partner and Chair of the firm's Financial Services Litigation Practice Group, and Alexandra Harwin, firmwide Executive Chair of the Discrimination & Harassment Practice Group, are lead counsel, working with Leigh Anne

Daly, et al. v. West Monroe, et al.: A class action in the U.S. District Court for Northern Illinois against consulting firm West Monroe Partners, alleging that senior executives short-changed current and ex-employees of approximately \$50 million by cashing out their holdings in an employee stock ownership plan. The buyback occurred only a month

before West Monroe sold a 50% stake in the company to a private equity firm in a deal that valued the company at \$2.5 billion. San Diego Managing Partner Charles Field is lead counsel, alongside Partner Russell Kornblith, Associate Sean Ouellette, and Associate James Hannaway.

Mattson, et al. v. Milliman, et al.: A class action in the U.S. District Court for the Western District of Washington against Milliman, Inc., an actuarial and consulting firm, for breach of fiduciary care under the Employment Retirement Income Security Act of 1974 ("ERISA"). Milliman, with annual revenues of approximately \$1.4 billion, has allegedly cost its employees as much as \$85 million in retirement savings by failing to remove poorly performing "target risk funds" from its 401(k) plan. San Diego Managing Partner Charles Field is lead counsel, and the team includes Meredith Firetog, David McNamme, and Ari Rubin.

New Fellowships at Sanford Heisler Sharp

In 2022, Sanford Heisler Sharp established two fellowships to honor the work and mentorship of two friends and colleagues who passed away in 2021. **Tom Henderson** spent his entire career as a civil rights advocate, and worked at Sanford Heisler Sharp for the past 13 years. **Deborah Rhode** was a Stanford Law professor and leading legal ethicist. Both The Tom Henderson Civil Rights Fellowship and The Deborah Rhode Fellowship are one-year appointments awarded to a junior attorney who has demonstrated academic excellence and a passion for and commitment to civil rights throughout law school.

Justice on the Horizon for Leonard Peltier

It has been an active year in the firm's representation of Leonard Peltier in his petition for clemency. Mr. Peltier has spent more than 46 years in prison following a controversial and at times blatantly unconstitutional trial in the aftermath of a firefight between the FBI and members of the American Indian Movement (AIM). A team of attorneys and legal assistants at Sanford Heisler Sharp, led by Co-Chairman Kevin Sharp, drafted and filed Mr. Peltier's petition for clemency with President Biden in 2021, and have been actively advocating for his release while the petition is pending.

This summer, the U.N. Human Rights Working Group issued a <u>detailed report</u> finding "overwhelming" procedural deficiencies and concluding that Mr. Peltier's continued incarceration is "arbitrary." In September of this year, the Democratic National Convention unanimously passed a <u>resolution</u> urging President Biden to release Peltier.

The end of this year has been marked by several significant developments in Mr. Peltier's case. In October, our team of attorneys submitted a response to the FBI's written opposition to clemency, highlighting the misleading and disproven claims underlying the FBI's position.

On November 13, Kevin Sharp spoke from the steps of the Lincoln Memorial to a large crowd which gathered to support clemency for Mr. Peltier. That week, Judge Sharp also moderated a panel with Sheron Wyant-Leonard and Dorothy Ninham—which aired on C-SPAN—at Georgetown Law School; they discussed the political motives behind Mr. Peltier's trial and continued incarceration. Judge Sharp

later met with several senators on the Hill to discuss support for Mr. Peltier's clemency petition.

Judge Sharp's advocacy kicked off a flurry of activity in Mr. Peltier's case, culminating in several key developments all occurring within a single week. On November 29, seven senators—Elizabeth Warren, Bernie Sanders, Brian Schatz (chair of the Senate Indian Affairs Committee), Patrick Leahy (the longest serving U.S. senator and former Judiciary Committee chairman), Ed Markey, Mazie Hirono, and Tina Smith—<u>issued a letter</u> urging President Biden to commute Peltier's sentence. On November 30, Politico kicked off its coverage of the White House Tribal Nations Summit with headline coverage of Mr. Peltier's case. On December 1, 216 artists in the entertainment and fashion industry also issued a letter to President Biden urging for the release of Mr. Peltier. The letter was led by indigenous members of the industry, including Dallas Goldtooth and Bird Runningwater, among others, and was signed by hundreds of allies, including: Mark Ruffalo, Ed Helms, America Ferrera, Paul F. Tompkins, Casey Wilson, Ringo Starr, Ani DiFranco, Bonnie Raitt, Tanya Tucker, Jackson Browne, Kris Kristofferson, Graham Nash, Rosanna Arquette, and many more. Finally, on December 3, former FBI agent and 9/11 whistleblower, Coleen Rowley, sent a letter urging President Biden to say "enough is enough" and allow Mr. Peltier to go home.

In Memory of Albert Woodfox (1947–2022)

Albert Woodfox, who died in August of complications from Covid-19, served 44 years of his life in prison. He spent most of those years in seclusion 23 hours a day, in a 6-by-9-foot cell at the Louisiana State Penitentiary built on a former plantation known as "Angola." Woodfox served this time for a crime of which he was innocent: the killing of a prison guard in 1972. Albert Woodfox is thought to have spent the longest period in isolation ever suffered by a human being in the U.S. penal system.

The cruel and unusual punishment endured by the trio of men known as the "Angola Three"—all of whom, it was believed, were targeted due to their prison activism and membership in the Black Panther party—drew international condemnation. It was Sanford Heisler Sharp's honor to join Albert's case in 2013, and to play a role in gaining his release in 2016, collaborating with other attorneys to defeat Louisiana's plan to recharge him for the guard's death.

Albert carried on his mission of ending the barbaric practice of solitary confinement in the U.S. penal system. In 2019, Sanford Heisler Sharp and the Neighborhood Defender Services of Harlem ("NDS") invited Albert to speak to members of the NDS. Kevin Sharp, the firm's Co-Vice Chairman and former Chief Judge of the U.S. District Court for the Middle District of Tennessee, introduced Albert after speaking about criminal justice reform. Albert spoke about prison reform and about his book, Solitary: Unbroken by Four Decades in Solitary Confinement. My Story of Transformation and Hope, which was a finalist for the National Book Award in Nonfiction and was a finalist for the Pulitzer Prize in General Nonfiction.
